Booth Rental

Booth rental for each meeting is payable in full to ALSHP and should be sent with the Exhibit Space Contract. Booth assignment is at the sole discretion of ALSHP and will be assigned based on date the contract is received, with corporate sponsors receiving highest priority. Electrical outlets are not included in exhibit fees. **Payment is due 10 days prior to event.**

Written cancellation requests received 30 days prior to the meeting date will be honored with a 50% refund of the booth rental fee. After that time, no refunds will be given.

Materials Shipping

Items must be properly packed and shipped to the attention of the company representative exhibiting. More details on shipping will be sent to the designated contact person prior to the meeting, as needed.
